## Oil Spill Liability (OSLTF)

**The Oil Spill Liability Tax is scheduled to expire December 31, 2025 unless Congress enacts legislation to extend it.**

**The OSLTF expired December 31, 2018 and was reinstated as of January 1, 2020.**

The tax is imposed on crude oil when it is received at a United States refinery. The operator of the refinery is the only party liable for the tax. The increase was mandated by Congress in the Energy Improvement and Extension Act of 2008. The Oil Spill Liability tax was enacted under the Bush Administration in 1991 in response to the Exxon Valdez 1989 oil spill in Alaska.

The "Oil Spill Tax" funds are used to defray costs of oil spills and other petroleum-related environmental clean-ups. This tax is paid by refiners and importers and can be passed on to the consumers of such products.

The Oil Spill line item fee is 9 cents per barrel (\$0.00214286 cts/gal) for clear gasoline and diesel fuel. The rate will vary slightly for products blended with ethanol and biodiesel depending on the blending percentage.

Most suppliers are billing the OSLTF tax as a "separate line item" and not including the fee in their posted price, while others have chosen to include the fee as part of the posted price.

DTN is working to provide the OSLTF information to our FastRacks customers in a format that is acceptable to the user. We will offer our price reports in three ways:

- No modification to the prices at all (reported as suppliers post their price)
- Prices with the OSLTF added to the suppliers that bill as a separate line item (all prices will have the OSLTF added)
- Prices with the OSLTF removed from the suppliers that include the fee in their posting (all prices will have the OSLTF removed)

## Superfund

**The Hazardous Substance Superfund Financing Tax Rate on Crude Oil and Petroleum Products was reinstated effective January 1, 2023.**

It allows the EPA to clean up contaminated sites. It also forces the parties responsible for the contamination to either perform cleanups or reimburse

the government for EPA-led cleanup work. When there is no viable responsible party, Superfund gives EPA the funds and authority to clean up contaminated sites.

As of January 1, 2026 Superfund tax rate remains 18 cents per barrel (.00428cts/gal) on crude oil and petroleum products and may be adjusted yearly for inflation. This is in addition to the current Oil Spill Liability Trust Fund tax (OSLTF).

Most suppliers are billing the Superfund tax as a "separate line item" and not including the fee in their posted price, while others have chosen to include the fee as part of the posted price.

DTN will not be adjusting for the Superfund tax – prices will be reported as suppliers post them.
